Mail this completed form, the original UPC code from the product package of the GSP-1700 phone (no UPC code required for the SATFI and GSP-2900 products; check product purchased below), the service activation confirmation email for your GSP-1700, Sat-Fi or GSP-2900 (renewal notices and billing histories will not be accepted), and a copy of your sales receipt with the eligible product circled. **Must be postmarked no later than 2/03/2015.**
