

# Raymarine® Dragonfly Screen Capture Competition

## OFFICIAL RULES & VOID WHERE PROHIBITED.

- 1. ELIGIBILITY:** The Raymarine Dragonfly Screen Capture Competition ("the Competition") is only open to individuals who are eighteen (18) years of age or older as of December 31, 2012 (the "Entrant"). Employees of Sponsor (as defined below), and its respective parent companies, affiliates, subsidiaries, officers, directors, employees, contractors, representatives and agents, and each of their respective immediate family or household members (collectively the "Released Parties") are not eligible to enter the Competition.

- 3. SCREEN CAPTURE GUIDELINES:** Screen captures must be submitted as a digital file to [dragonfly@raymarine.com](mailto:dragonfly@raymarine.com). No images supplied in hard copy will be accepted. Screen captures must be taken from the Raymarine Dragonfly Sonar-GPS display. Screen captures from other products will not be accepted. All entries must be correctly labeled with the entrant's full name, address, telephone number, brief description and the location of the screen capture. Entrants must have registered their Dragonfly product online. Entries will not be returned. Submission of a screen capture does not guarantee publication. There is no limit to the number of times an Entrant can submit an Entry, but any Entrant can only win a maximum of one of each prize. - 4. COMPETITION ENTRY PERIOD:** An Entry will only be accepted if received on or between April 1, 2013 at 12:00:01AM Eastern Time (ET) and December 31, 2013 at 11:59:59 PM ET (the "Entry Period"). The Sponsor's Website database clock will be the official timekeeper for the Competition. Any Entry that is received outside of the Entry Period will be disqualified and discarded.
- 5. MONTHLY GRAND PRIZE, ARV, AND ODDS OF WINNING:** The Monthly Grand Prize shall consist of one (1) entrant being reimbursed for the cost of their Raymarine Dragonfly Sonar-GPS system (excluding installation costs), total approximate retail value (ARV) of Seven Hundred Twenty Dollars (\$720.00.) The entrant may be requested to furnish a valid invoice or receipt showing the purchase price paid for the Dragonfly Sonar-GPS System. The odds of winning the Grand Prize depend on the number of eligible Entries received during the Entry Period.
