Please read through all of these Instructions and tips before proceeding with the installation. We do our best to provide a simple installation process for all applications, however a professional installation is always recommended.

IMPORTANT

Always disconnect any power sources connected to your vehicle before servicing fuses or electrical systems.

NOTE:

- 1. Radiance lights are designed to operate from 9V-16V only. Using this product on a 24V or higher system will cause permanent damage to electrical components.
- 2. Backlighting and forward projecting LED's are intended for off-road use only.

FUNCTIONALITY:

The Radiance+ RGBW Series utilizes switch logic to change backlight colors. To choose from one of the 8 available backlight color options:

- Switch backlight on-off-on-off within less than 1 second
- Continue switching off and on until desired color is selected
- Once desired color is selected, keep back light on for more than 1 second to save color backlight color is locked in until process is repeated

NOTE: The Radiance+ RGBW lights contain a syncing function. Lights wired on the same circuit will sync together when color selection switch logic is initiated.

Order of backlight options:


- Red
- Green
- Blue
- Purple
- White
- Amber
- · Light blue
- · Rotating color mode

- **G** 5/16-18 Nut






MOUNTING INSTALLATION INSTRUCTIONS:



- **C** 1/4" Flat Washer (2)
- **D -** #10 Flat Washer (2)
- E Mount Bushing (2)
- **F -** 1/4-20 Nylock Nut
- **G** 10-24 Nylock Nut
- **H** Mount Bracket
- I 3/8" Carriage Bolt
- J 3/8" Flat Washer
- K 3/8" Split Washer
- L 3/8" Hex Nut




Light Bar

- **A** 1/4" Nylon Locknuts (2)

- A 1/4" Nylon Locknuts (4)
- **B** Mounting Bracket (2)
- C Mount Bushing (2)
- **D** 1/4 20x3/4" Hex Head Bolt (4)
- **E -** 1/4" Flat Washer (2)





WIRING HARNESS INSTALLATION INSTRUCTIONS:

- 1. Always disconnect the negative battery terminal when working with any electrical circuits.
- 2. When routing wires through any metal or abrasive surfaces, be sure the surface is free of any sharp edges.
- 3. Match the light pigtail to the harness colors: Red to Red (Forward projecting LED +12v trigger), White to White (back-lighting LED +12v trigger), and Black to Black (shared ground) using butt connectors



- 4. Find a desired location for switches and drill a 3/4" hole for each switch.
- 5. Connect leads from wire harness to switch using the following diagrams.



- 6. Route main power and ground leads from the harness to the battery terminals and attach the RED lead to battery +12v and the BLACK lead directly to the battery ground.
- 7. Re-connect the negative battery terminal and test switches to verify functionality.
